Credit cards are the most widely used form of payment for everyday shopping, online purchases and especially by travelers. Every credit card purchase generates an authorization request which is transmitted to and processed by a special facility called a "processing center".

Authorization control systems are processing thousands of requests every second 24 hours a day. Every minute of server downtime negatively affects every aspect of the links

between the bank, the processing center and the individual "shopper". If customers are unable to make their purchases, the reputation of the card-issuer bank can suffer and the number of clients supported by the processing center may decrease.

Multicarta takes pains to ensure that the heart of its system, their authorization servers, have the highest degree of fault resilience and high availability possible.

The Solution

Multicarta utilizes two HP ProLiant DL580 G3 servers with Red Hat Enterprise Linux AS 4 accessing an EVA 6000 shared storage array as a hardware platform for its authorization control system. The key software component is an IBM Informix database – it processes and stores the critical authorization data.

This system must be available 24/7/365 as a key element for supporting the company's IT strategy. When choosing a high availability solution, Multicarta's IT-team was searching for a product that could ensure not only seamless server failover but also the IBM Informix database.

After thorough market analysis IT officers concluded that SIOS' LifeKeeper suited their needs best of all, meeting and even exceeding some of their key performance indicators. The decision was made to purchase and deploy LifeKeeper for Linux along with the LifeKeeper Informix ARK – which provides Informix database support. This integrated solution was deployed by Aflex Software, an authorized SIOS partner in Russia. The system was configured by Aflex support and deployed by Multicarta's in-house IT officers to test and fine-tune the complete system. During and after the deployment Aflex's engineers provided appropriate consulting, training and support needed to start the system on time and maintain its operation.

Since the end of the testing period in July 2007, LifeKeeper assures uptime and availability of Multicarta's authorization control servers. Multicarta's IT staff benefits from the solution's capabilities.
